National Library Week April 4 – 10

On February 8, 2019 the United States joined the Marrakesh Treaty which allows participating libraries to access material in other languages from around the world. This treaty addressed the widespread problem know as a "book famine," – the situation where few books are published in formats accessible to those who are blind or visually impaired. Only about 7 % of published works are made available globally in accessible formats. Now accessible materials may be made and supplied to a person or library, within a country or across a national border.





Earth Day - April 22

Babe Ruth Day

Observed annually on April 27th since 1947 when Babe Ruth was invited to address a crowd of 58,339 fans in Yankee Stadium. He had recently been diagnosed with throat cancer and "spoke in a quiet, raspy voice and needed help walking." His words were broadcast across the country. On the 25th anniversary of Yankee Stadium on June 13, 1948, he was honored one last time. Number 3 was retired by the Yankees that day, never to be worn again. It would be just the second retired number in the franchise history, after his good friend Lou Gehrig in 1939. Babe Ruth died on August 18, 1948 at the age of 53.

Legislative Update

On March 20th, 2021, the 55th Legislative Session adjourned at noon. This was truly a unique session. It was mostly virtual with the public having to watch or participate via zoom or websites.

Legislators introduced 933 pieces of legislation during the session. Of those, 158 passed both chambers and have been sent to the Governor for her signature. She has until April 9th to sign, veto or pocket veto the bills. Come to our April 14th meeting to learn the results for bills as well as information on the Special Session.

Here are some bills particularly important to educational retirees:

SB 303, Change Ed Retirement Board Member. This will increase the number of ERB trustees from a seven to a nine. It will add a representative from AFT as well as the Secretary of Higher Ed or their designee. (AFTNM president Stephanie Ly writes, "We want to thank Senator Sedillo Lopez, Majority Leader Stapleton, and the members of the House and Senate who voted for SB 303 and spoke up for educators having a seat at the table during decisions impacting their pensions in the ERB. We look forward to Governor Michelle Lujan Grisham signing SB 303 into law.")

SB 21a, Retiree Health Care Act. This legislation amends some language and definitions to conform with the Federal Patient Protection and Affordable Care Act.

SB 42aa. Increase Ed retirement Contributions. This increases the employer (*state*) contributions by 1% for 2022-2023 (\$34 million) and calls for a study to be performed on how to improve ERB's solvency without the addition of further monies from the General Fund. (*This bill was amended from 1% for each of four years to 1% for two years – look for another*

request supporting the ERB in coming years.) This bill was also amended to extend the Return to Work from 2022-2024.

The FCC has mandated the adoption of a 988 Suicide Prevention Hotline to be Implemented by July 16, 2022. However, to make this change in New Mexico, the state is required to move to ten-digit dialing for all telephone calls made in the state. The 10-digit local dialing is to prevent problems with reaching the National Suicide Prevention Lifeline using the 3-digit 988 code. On April 24, 2021, the ten-digit permissive dialing period will begin, but seven-digit dialed calls will still complete. On October 24, 2021, ten-digit dialing will become mandatory, and seven-digit calls in New Mexico will not be completed. You will get a recording telling you to hang up and dial again using the 10-digit number.

- Your telephone number, including current area code, will not change.
- The price of a call, coverage area, or other rates and services will not change due to the dialing change.
- What is a local call now will remain a local call regardless of the number of digits dialed?
- You will continue to dial 1+ the area code + telephone number for all long-distance calls.

If you have automatic dialing or preprogramed numbers, now would be a good time to add the area code to these numbers. And don't forget to add the area code to your personal ID tags as well as any pet ID tags.

Suicide Lifeline

Currently the National Suicide Prevention Lifeline is 1-800-273-8255. Beginning July 16, 2022, dialing "988" will route your call to the National Suicide Prevention Lifeline. Customers must continue to dial 1-800-273- TALK (8255) to reach the Lifeline until July 16, 2022
