Hearing Aids May Boost Longevity But Must Be Used Regularly

A new study has found that restoring hearing loss with hearing aids may lengthen people's lives. Dr. Janet Choi, an otolaryngologist and her colleagues tracked the status of nearly 1,900 adults who had a hearing loss.

They found that patients using hearing aids regularly had a 24 per cent lower risk of mortality compared to the group who never used hearing aids. Previous studies had shown the negative impacts of untreated hearing loss but Dr. Choi did not expect such a big difference in mortality risk.

It could be that people who regularly use hearing aids are also more likely to stave off isolation, remain more active, or have reduced risk of falls, which could explain their increased longevity. The effect held up even when the researchers took into account differences such as age, ethnicity, education, and medical history.

Approximately 40 million adults in the U.S. have hearing loss, but most don't use hearing aids. Given the benefits, Dr. Choi says it's stunning how few people with hearing loss wear hearing aids regularly—just 12 per cent, according to her study. Another striking finding was that the people in the study who had hearing aids but didn't use them regularly were as likely to die prematurely as those who never used them.

Turning the Heat Up On Planet Earth

The United Nation's weather agency and Europe's Copernicus Climate Change Service indicate that 2023 has been the warmest year on record globally. On average, Earth in 2023 was approximately 2.61 degrees warmer than in preindustrial years. And a new study finds that the ocean surface is now warmer than any other time since satellite records began. Rising ocean surface temperatures could bring super-charged storms around the world.

The Story of Our Flag

The first flag of New Mexico statehood was authorized in 1915. It featured a blue field with a miniature U.S. flag in the upper left corner, the state's great seal in the lower right corner and "New Mexico" diagonally across the field from lower left to upper right corner. Our beautiful yellow and red flag did not become the official state flag unit March of 1925.

The NM chapter of the Daughters of the American Revolution (D.A.R.) wanted a flag that represented New Mexico's unique character. They held a design competition which was won by Santa Fe physician and archeologist, Dr. Harry Mera. It is a modern interpretation of an ancient sun design found on a late 19th water jar from Zia Pueblo. The red rays represent the four: seasons (spring, summer, fall, winter), directions (north, south, east, west), times of day (dawn, day, dusk, dark), and times of life (infancy, youth, adult, old age).

The Zia proportions are fixed by legislative act, with the four groups of rays set at right angles, the two inner rays one-fifth longer than the outer rays. The diameter of the circle in the center is one-third the width of the symbol

ERB - Educational Retirement Board

The ERB's communication team has been promoting and conducting a "virtual" Road series, in addition to their onsite presentations. Each month they will present a webinar. NMRHCA – New Mexico Retiree Health Care Authority

Last year, in and effort to control health care costs and with the support of Governor Michelle Lujan Grisham, the legislature passed SB 16. This bill created a new state agency named the Health Care Authority (not to be confused with the *Retiree Health Care Authority*). Gov. Lujan Grisham said, "The HCA's creation marks a monumental step toward enhancing health outcomes, cost-effectiveness, health care accessibility, and the overall welfare of our state's residents." It was unclear what this meant to the *Retiree Health Care Authority*. Would this limit the number of choices of health care providers for NMRHCA members? Who would make those decisions? What about the trust fund that the NMRHCA has set up to maintain its sustainability?

The new agency, HCA, is set to launch on July 1, 2024. This will be a merging of the New Mexico Human Services Department (HSD), the State Employee Benefits Bureau from the General Services Department, and the Division of Health Improvement and Developmental Disabilities Support Division from the NM Department of Health.

On January 2, it was announced that the final report will no longer include a proposal to "administratively attach the New Mexico Retiree Health Care Authority to the HCA." The NMRHCA will continue as it has in the past to offer various health care options to retirees at an affordable price and to maintain a trust fund to ensure that this is available long into the future.

The NMRHCA is planning on two legislative proposals: (1) a one-time request for \$150 million to help lower liabilities and mitigate rising costs to members and (2) a joint (House & Senate) resolution for NMRHCA to be recognized and protected under the New Mexico Constitution, similar to the Educational Retirement Board (ERB) and Public Employee Retirement Association (PERA).


At this time no sponsors for these measures have been identified.
