## NM Primary June 2, 2020

With the uncertain timeline for social distancing you should consider an absentee ballot. Absentee voting begins Tuesday May 5. Go to <a href="MVote.org">NMVote.org</a> to request an application for an absentee ballot or fill out an online application. No excuse is required to vote with an absentee ballot.

Requests will be accepted until Thursday, May 28th. Requests must be made by this deadline in order for the absentee ballot to be mailed by the appropriate county clerk in a timely manner. Absentee ballots can be returned to your County Clerk's Office, an early voting location prior to Election Day or any Election Day polling site.

#### **Yikes and Thanks!**

According to a report from the American Diabetes Association in 2017, "People with diagnosed diabetes incur average medical expenditures of \$16,752 per year, of which about \$9,601 is attributed to diabetes specifically."

Governor Michelle Lujan Grisham signed House Bill 292 which caps the monthly cost of insulin for diabetes patients at \$25, the lowest copay in the country. She said, "Helping diabetes patients is a priority." Insulin prices have nearly tripled in the last ten years.

## **AFT Endorses Joe Biden**

Acting on a clear mandate from AFT's membership, the AFT national executive council passed a resolution endorsing former Vice President Joe Biden for president. After more than a year of member engagement on the endorsement process – with more than 300,000 AFT members nationwide participating in candidate events, town halls, polls, regional conferences and other efforts – new membership polls show strong support for Biden.

## <u>AFT History - Did You Know?</u>

May 17 marks the 66th anniversary of the Supreme Court's ruling in Brown vs. Board of Education, which determined that segregating schools on the basis of race was "inherently unequal" and thus, unconstitutional. AFT filed an amicus curia brief in the historic 1954 Supreme Court desegregation case Brown v. Board of Education of Topeka. Previously in 1953 the AFT had amended its constitution to provide that "No charter of the AFT which defines or recognizes jurisdiction on the basis of race or color, or permits the practice of such jurisdiction, shall be recognized as valid, and the practice of any such local in limiting its membership on account of race or color shall render its charter void." The federation willingly suffered the loss of thousands of members in 1957 when it expelled its remaining segregated locals in the South.
